SECTION 4: First aid measures

4.1. Description of first aid measures

- First-aid measures general : Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves.

Take up mechanically (sweeping, shovelling) and collect in suitable container for disposal. Following product recovery, flush area with water. Small spills: Wipe up with absorbent material (for example cloth). Clean surface thoroughly to remove residual contamination. Never return spills in original containers for re-use.
