## SECTION 4: First aid measures

### 4.1. Description of first aid measures

Following product recovery, flush area with water. Small spills: Stop leak without risks if possible. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.
